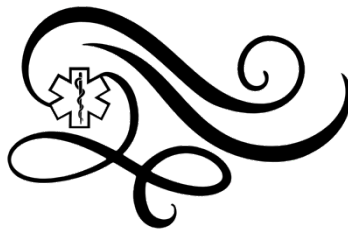

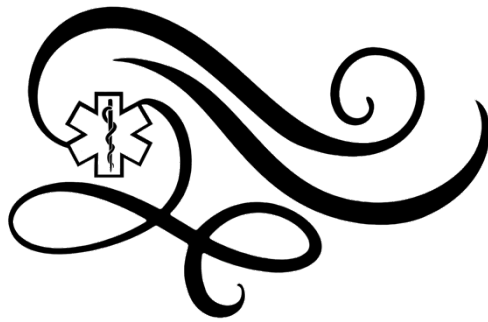

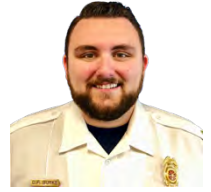
William J. Bullock, MPA, EMT-P Chapter 22

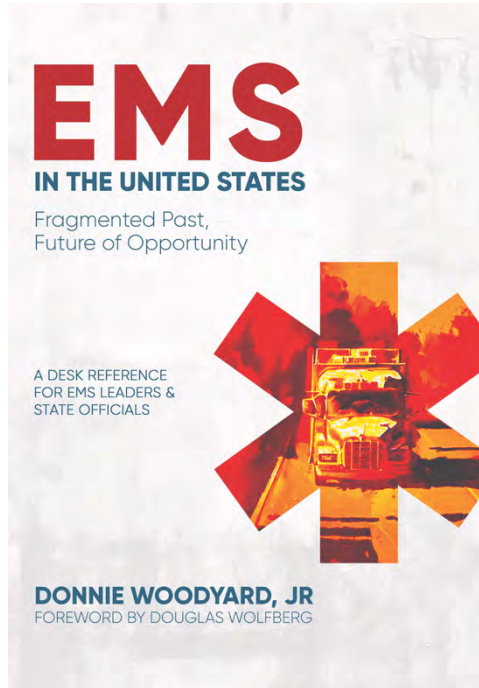

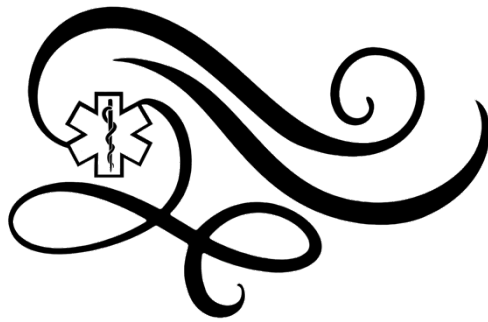
